	The applicants who were junior than the applicants Sl. No. 1 to 6 included in the tentative seniority list have already been appointed in the Department under Die-in-Harness Scheme.	These applicants' appointments were made after following due process. Earlier, separate seniority lists were maintained for the Transport Department and the MSRTC, which are now both under the Transport Department, Government of Manipur. The tentative seniority list published on 8 th September, 2025 covers both the deceased employees of the Transport Department and the MSRTC
	The applicant in Sl. No. 7 Seniority shows that the date of submission of application at the Department in the seniority list published earlier is 29 th September, 2016. Later in the tentative list it shows 4 th October, 2007.	No official final seniority list has been published by the Department since 2014, except for the tentative list notified on 8 th September 2025.
2	Sl. No. 2 has been wrongly recorded as "Maibam Surjitkumar Singh, S/o (L) Maibam Ibohan Singh" in place of "Maibam Surjitkumar Singh, brother/o (L) Maibam Ibohal Singh"	Rectified in the list after due verification.
3	As per the tentative seniority list, Sl. No. 2 was an underage at the time of expiry of the Govt. servant, thereby, objecting to the case of inclusion of Sl. No. 2 in the list.	In this regard, clarification has been sought from DP.
